As a teenager, Rabbi Lopiansky went to the Mir Yeshiva in Yerushalayim, and soon thereafter became the Rosh Yeshiva's, R' Beinish Finkel's, son-in-law. He continued learning and was involved with the Mir Yeshiva from 1970-1995, where he was a talmid of R' Chaim Shmulevitz and R' Nochum Partzovitz. During that time, Rabbi Lopiansky also taught students in Aish HaTorah from 1983-1990. In 1995, he came to Silver Spring, MD to be the Rosh Yeshiva of the Yeshiva Gedola, and he has remained there since. Rabbi

Lopiansky has authored many works, including a siddur, machzor, Tefilla l'Moshe - Rishonim on Tefilla, Maharal Ner Mitzvah, G'vuros Hashem, Maharal on Brachos, Yesodei Hatorah and Time Pieces. He has written many articles for the Jewish Observer, Klal Perspectives, Dialogue, Jewish Life, and Aish.com. R' Lopiansky is highly sought after as a scholar in residence around the world. Besides his shiurim in yeshiva, he delivers routine shiurim in Passaic, NJ, Columbia, MD, Baltimore, MD, and a tele-shiur to London.
